## Tribal Council action to close Kah-Nee-Ta

The Confederated Tribes of Warm Springs Tribal Council took formal action Tuesday to close the Kah-nee-ta Resort & Spa, putting into motion the recommendation of the Board of Directors. The closure includes the Lodge, the Village, and the golf course. Immediate steps will be taken by the Tribes Executive Management team and the Board to implement a closure plan.

The Kah-nee-ta Board of Directors has presented a number of ecotourism options to the Tribal Council for consideration over several

sessions. These ideas included a trial season of heli-skiing on Mt. Jefferson, multi-day lodge-based fishing trips along the Deschutes River, trophy game hunting, and the development of a culture and wellness center. Each of these options required action by the Tribal Council to move forward as permitting and capital investments were needed.

The Board also included permitting areas on Mt. Jefferson for limited commercial film and photography production. The permits would

have generated revenue for the Tribe and resort as well as generated jobs and other opportunities for Tribal members. Other tribal nations have departments that manage commercial production including the Navajo Nation Parks and Recreation Office who permit commercial film and photography production for Navajo Nation lands. This branded permit concept was previously presented in 2017 to generate revenue for the Scholarship Fund and infrastructure development but did not receive enough support to move

forward.

After lengthy discussions and no action on presented options, Councilwoman Carina Miller made the motion to move forward with closure of the facility on September 5th. "It is irresponsible to continue pouring money into an enterprise that has demonstrated over many years that it cannot generate enough revenue to cover expenses," she stated.

## Water plant to see needed improvements

Through a combination of grants the Confederated Tribes now have the funds to make some significant improvements to the Dry Creek Water Treatment Plant.

The final piece of funding—\$447,000 from the Department of Housing and Urban Development—adds to an earlier \$343,000 from the Bureau of Indian Affairs, and \$80,000 from Indian Health Service—Portland Area Office. That brings the total available to \$870,000, all to be used for improvements at the treatment plant.

Tribal management and the Community Development Director have been focusing on finding a solution for the treatment plant,

built in the early 1980s and now 36 years old. The Environmental Protection Agency and the tribes identified specific areas that need to be addressed.

With an aging system, replacement parts can be hard to come by, and must more expensive than when the plant was built.

The situation had become a serious concern, qualifying the grant request in the 'imminent threat' category. The grant application also demonstrated that existing tribal resources were not currently sufficient to address the immediate needs.

The \$870,000 upgrade will allow the treatment plant, on the

Deschutes River, to continue operating for the next five or so years. That gives the tribes time to find funding for a new treatment plant, with the current preferred site also at the Dry Creek location.

The recent grants should allow improvement work to begin this year. The single biggest part of the project is the pumping system. The plan is replace existing pumps and purchase back-ups, total estimate of \$175,000.

A new computer system and electrical panels controlling the facility are also a big component, at \$148,000.

Then there are a number of other aspects, accounting for the

rest of the \$870,000. All of this will be a welcome project for the tribes. As the grant application points out:

The condition of the treatment plant "is a very real concern to the elected tribal officials and management, because more than 4,000 tribal residents may be without water for their daily activities because of water pump failures."

Meanwhile management continues to work with the IHS and other agencies, planning for a new plant, estimated cost of \$16-to-\$22 million. This would be a much more modern facility.

## Council establishes Veterans program

Tribal Council this week approved an agreement with the Oregon Department of Veterans Affairs that provides Warm Springs with tribal veteran service officers.

The Warm Springs service operators will be available to help the veterans of the community with efforts such as acquiring veterans benefits.

The Oregon Department of Veterans Affairs is required to file an application for accreditation with the U.S. Department of Veteran Affairs for each person the department desires to be certified as a representative of the organization.

In order to acquire the necessary certification for the Warm Springs veteran service officers, the Council and Oregon Department of Veterans Affairs entered into a memorandum of under-

standing, signed by Council Chairman Austin Greene Jr. on Monday of this week.

On behalf of the Department of Veterans Affairs, acting department director Mitch Sparks also signed the agreement.

## BIA to inspect W.S. Jail conditions

Bureau of Indian Affairs Law Enforcement from Portland plans to visit Warm Springs to tour the jail. The Warm Springs Jail and dispatch building is BIA property, operated by the tribes through the Public Safety Branch.

BIA law enforcement plans to inspect the facility in mid September, said Agency Superintendent Lori Anderson, meeting last week with Tribal Council.

Condition of the Warm Springs Jail has been an issue with the tribes for years.

The facility was built in 1985 with a projected useful life of 25 years.

A new or wholly renovated facility is needed to address the basic infrastructure problems.

The U.S. Department of Justice, through the BIA Office of Justice Services, has been identified as a possible source of funding.

Nevertheless, regarding the upcoming visit from BIA law enforcement visit, “We’ve had these reviews and reports for years, and so far nothing has been done about it,” said Tribal Councilman Jody Calica.

## State closes Columbia fishery

Optimism earlier this year about the Columbia River summer steelhead runs proved to be premature, and the states of Oregon and Washington took unprecedented actions in August to protect diminished returns of wild steelhead.

Oregon shut down the Columbia River to all fishing at the mouth of the Deschutes River.

The numbers of returning summer steelhead have been low enough that fisheries managers do not believe the run will come in as strong as expected. The 190,000 projected 2018 return may actually come in closer to 110,000.

## Welcome cooling eases fire, smoke

The reservation experienced a hot and smoky month of August. Recent cooling has given a welcome break from the conditions.

The Tenino fire burned in August, scorching about 9,500 acres.

This fire contributed to the smoke, but most was coming from fires in Washington and British Columbia.

The air quality was recorded as moderate on most days, though twice the reading was ‘unhealthy,’ meaning people with certain conditions were encouraged to stay inside.

While Warm Springs was smoky in August, the situation was worse in the Madras area. This is because the agriculture field burning

added to the wildfire smoke. Through an agreement, the Jefferson County smoke program does not allow field burning when the wind is blowing toward Warm Springs.



## Tribes engaged in bridge project

The Port of Hood River made efforts in August to include the Columbia River Intertribal Fish Commission and representatives from the Washington side of the river in the bridge replacement process.

The most significant step was a \$25,000 contract, approved by the port commission.

The calls for working with Akana Engineering to help coordinate with CRITFC and the four member tribes: Warm Springs, Yakama, Umatilla nad Nez Perce.

Under this contract, Akana, a Native American-owned professional services firm, will advise on tribal outreach and facilitate contact with key tribal representatives.

The company has 10 offices nationwide, with its headquarters in Portland.

The Bus Project is a vol-

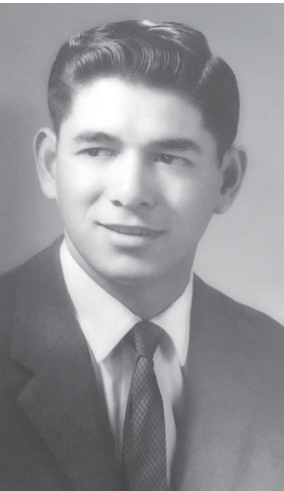
unteer-driven, non-profit organization that engages young people in the political process. A focus is on registering to vote.

The Chinook-Holliquilla Gathering

In the year 1823 at the Wascopum village at the Columbia River, the child Young Guygo was born.

Young Guygo was orphaned at an early age, his parents probably taken by one of the many diseases brought to the area by the non-Indian settlers.

As a teenager Guygo moved to Ft. Dalles, living for a time at the Mission with the Reverend Daniel Lee and family, where he learned English.

The reverend in 1835 baptized Young Guygo and gave him the Christian name William ‘Billy’ Mackendrie.

Sometime later he moved in with the Perkins family, who were Chinook Indians.

Cpt. William Fremont arrived at Ft. Dalles in 1842, as he was mapping trails and waterways of the West for the U.S. government.

Fremont recruited Billy to join the expedition. Believing Billy was a Chinook Indian, Fremont called him Billy Chinook.

In the ensuing years, Young ‘Billy Chinook’ Guygo traveled to California, east to Nevada, and eventually to Washington, D.C., where he attended Columbia College.

He lived in Pennsylvania, living with Quakers, where he acquired his preferred name, William Parker.

In time he traveled back to California, probably having some luck with gold mining, and then finally returning to Oregon.

In his middle and later years he lived on the Warm Springs Reservation, farming and ranching, marrying more than once. He and his wife Annie Holliquilla had a daughter, Emma Parker...

*This is a very abbreviated account—based on a history by Richard Macy— of the fascinating life of William ‘Billy Chinook’ Parker, whose memory was brought to life this month at the Great Clan Gathering. At the gathering Mr. Macy shared some great old photographs, and a family tree as long as the gymnasium wall.*

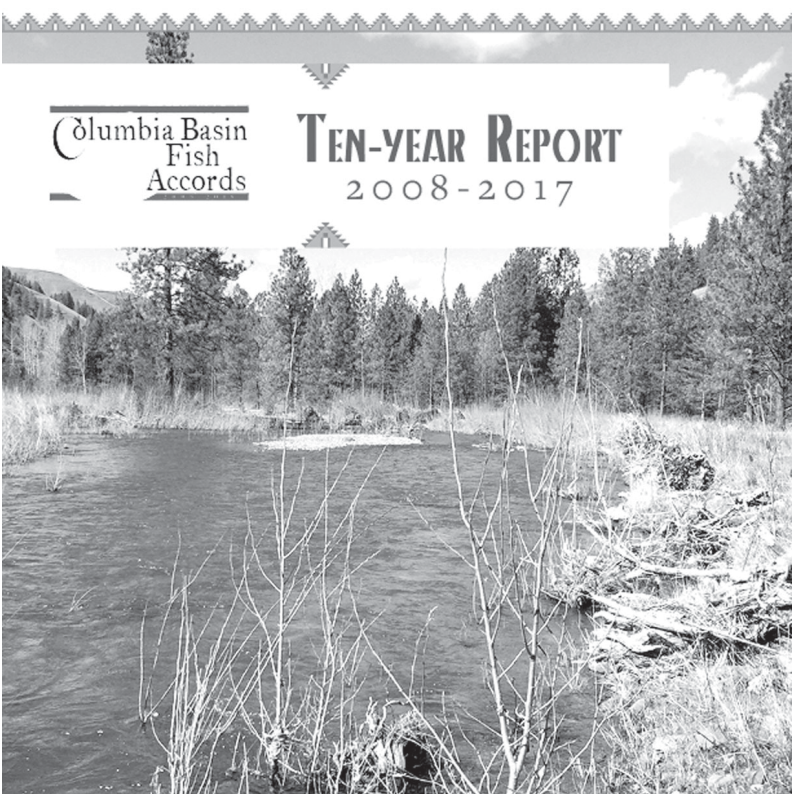

## CRITFC report reviews historic Fish Accords

This year marks the Ten Year Anniversary of the signing of the Columbia Basin fish Accords. It was on 2008 the Warm Springs, Yakama and Umatilla tribes, and the Columbia River Inter-Tribal Fish Commission signed the Accords. On behalf of the federal government were the Bonneville Power Administration, Army Corps of Engineers, and Bureau of Reclamation. CRITFC explains the significance of the Accords: *The partnership they forged ushered in a new era of regional salmon restoration and financial predictability. The Accords provided secure funding for long-term habitat restoration and fish survival and passage improvement projects at the dams. These projects furthered the tribes' Wy-Kan-Ush-Mi Wa-Kish-Wit vision to maintain and enhance salmon populations for future generations. The increase and security in stable*

*funding that the Accords provided allowed the tribes to implement more complex and larger projects not possible under the previous funding methods. The BPA gained a ten-year period of certainty for hydro-*

*power generation during which the tribes agreed to not litigate for additional fish protection at the dams or the breaching of the Snake River dams. By working together, the parties shifted their relationships from adversarial to one based on negotiation and collaboration and the region and salmon benefited as a result.* CRITFC just released its Ten Year Report on the Columbia Basin Fish Accords. This detailed report gives a thorough overview of the tribal projects and results of the Fish Accords. An example: “Forty percent of the Warm Springs, Yakama, Umatilla and CRITFC Accords funding went to watershed restoration efforts. Over the course of the last decade, they completed **14,586** in-stream actions and **404** out-of-stream actions.” You can see the full report at [critfc.org](http://critfc.org)

The college hosts the Constructing Hope pre-apprenticeship camp. This is an opportunity for the young people to learn about a variety of fields in construction: Journeymen, welding, environmental restoration, masonry, heavy equipment, etc.

As part of the program, the Warm Springs youth visited the Street of Dreams in Portland, where many construction trades are being practiced, including the renovation of an elementary school.

Leonard Polk, 17, is a high school senior interested in heavy equipment operation.

The camp this summer, he says, “was cool because we learned all

The program includes a first aide/CPR session before each

project. They worked with sheet metal, and ‘dingo,’ a small version of a backhoe.

Constructing Hope is open to youth between 16 and 19 years of age.

Both Councilwoman Val Switzler and Bridgett McConville shared similar concerns. The final vote was three yes and five abstentions with the Chairman not voting.

In the coming week, Kah-nee-ta staff will finalize inventory of assets and turn them over to the Tribes. The Secretary Treasurer/CEO and Chief Operations Officer are responsible for integrating the closure costs into the tribal budget and managing the assets moving forward. Residents of the Hamlets have been informed that their housing is secured through December 31st. It is estimated that the closure costs will be up to \$720,000 annually.

“The shuttering costs are significant and will put a burden on an already challenging budget year,” stated Austin Greene, Tribal Council Chairman.

Vice Councilman Charles Calica added that, “while we have now set a date for closure, it does not prevent the Tribal Council from pursuing options for financing and the facility. This will be necessary to reduce the costs to the Tribal government.”

This weekend, a number of activities will be held at Kah-nee-ta including a horse parade and salmon bake at the Lodge on Saturday. Community members are invited to participate in this all volunteer gathering by cooking, dancing, or riding in the horse parade. 
