## Plan developing for Business Incubator move

The land is clear for the Community Action Team Business Incubator, just off the highway.

Some of the next steps in the process are the site survey and a geo-tech survey, said Marissa Ahern, Business Incubator project manager.

These surveys should start happening within the next few weeks, Ms. Ahern said. So we'll start seeing the surveyors and others working at the construction site.

Next will be the pouring of the building foundation; and some mitigation work at the Commissary itself, to remove lead paint and potential asbestos, for instance.

September is a target month for the actual move of the building, which will be a unique sight: The building will be lifted up on stilts, and then loaded onto a truck, Ms. Ahern said.

The vehicle will then make its way slowly over the couple of blocks to the new site. This will be great renovation of the area.

The Community Action Team planning a community outreach this year, identifying the retail businesses that will join the Incubator team.

And there will be a website launch. Marissa has worked with

filmmaker LaRonn Katchia on developing video for the website.

For the project the Action Team has worked with many lending sources, with great success; and with a leading architecture firm, Hacker Architects, who have donated their services.

So far the retail businesses for the Incubator include the Tananawit artists group, and a cafe. Upstairs will be office space, including for the Action Team small business coach.

The long-term plan calls for an outside food court, and the Action Team has advertised for a food cart manager-trainer.

The old Commissary building is thought to be the oldest structure on the reservation, dating back to the late nineteenth century. It's been vacant for a number of years now.

## Getting ready for start of school

The month of August means school will be starting soon, in about a month. The first student day at the Warm Springs Academy and other 509-J schools is Tuesday, September 3, the day after Labor Day.

The Academy reminds incoming kindergarten families that the students need to be enrolled for the coming 2019-2020 school year.

Kindergarten conferences and Summer School for kinders will start soon. Turn in registration packets to Heilan at the school district office in Madras, 445 SE Buff Street.

In other recent school news:

### Senate Bill 13

Following a presentation by Valerie Switzler, general manager of the tribal Education Branch, the Tribal Council this week endorsed the effort to implement Senate Bill 13.

The Oregon legislature adopted SB13 in 2017, with advocacy from tribes.

The law requires the state Education Department and school districts to work with tribes in developing a Native American curriculum.

This curriculum will give the tribal perspective on history, culture and heritage, tribal sovereignty and treaty rights, and current economic conditions and events.

Since 2017, Warm Springs Culture and Heritage has been working with elders and others in developing the curriculum since 2017, with the implementation in the school district this coming school year.

## Entering month four of boil water notice

It was back in May that the tribes found chlorinated water leaking into Shitike Creek. After some research, tribal Management and Utilities reported a worst case scenario: The 14-inch water pipe serving the Agency area had broken underneath the creek.

The Twenty-Eighth Tribal Council—they had taken office just two weeks earlier—declared an emergency. And residents around the residents were issued the boil-water notice.

The notice applied to the entirety of the Warm Springs Agency area, including Kah-Nee-Ta, Wolfe Point, Sunnyside, Upper Dry Creek, Miller Heights, Campus area, West Hills, Tenino Valley, Tenino Apartments, Elliott Heights, Senior Housing, Trailer Courts and Greeley Heights.

August will be the fourth month that the notice has been in effect, an unprecedented condition for the reservation.

There was some hope that repairing the water break—an expensive project for the tribes in

these lead budget times—would resolve the problem.

What happened, though, was the repair of the main break led to new breaks.

The problem has been the old pressure regulating valves, no longer functioning to regulate the water flow. In addition to the boil water notice, some residents experienced the loss of water pressure.

Many individuals, businesses, organizations and government agencies have offered and helped the tribes during water crisis. Examples are Indian Health Services, the BIA, and Housing, Urban Development. Water companies and agencies, other tribes, individuals and many others donated bottled water, and money.

Tribal Emergency Management has become the headquarters providing the bottled water to residents.

And for now the boil water notice continues, as the tribes are encouraging care and conservation.

Starla Green had her frybread concession cooking last week at the Jefferson County Fair and Rodeo. The frybread concession is an always popular addition to the fair.

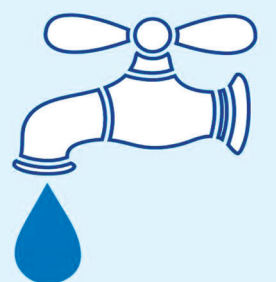
As Natives and others know, frybread is a versatile food: It can be enjoyed by itself, or with almost any kind of toppings.

According to some Native traditions, frybread was created in 1864 using the flour, sugar, salt and lard that was given to tribes by the federal government. Over the decades frybread has been a link from generation to generation, still as popular as ever.

# Council okays Sunnyside paving project

Tribal Council approved the Sunnyside Drive paving and improvement project, as presented by Warm Springs Construction and Ventures.

This is a more than \$2 million project, through BIA Roads, that will include two miles of paving—between Upper Dry Creek and Tmsh—plus a separated sidewalk, and solar-powered street lights.

The project will start in a couple of weeks, and is expected to take about three months.

Warm Springs Construction currently has about 12 employees; and when the Sunnyside project begins the total could be closer to 20, said Ben Bisland, of Warm Springs Construction. About 77 percent of the Construction employees are Warm Springs tribal members.

Some of the discussion before the Council vote was in regard to tribal member employment. Councilwoman Anita Jackson asked if Warm Springs Construction followed the TERO (Tribal Employment Rights Office) guidelines.

TERO ensures tribal

member employment, especially on the Oregon Department of Transportation road work projects on and nearby the reservation.

The TERO code as presently written would not apply to a tribal enterprise working on the reservation; and would apply to ODOT

rather than BIA Roads projects, the Construction team said.

Once the Sunnyside work starts, Construction will likely be using workers registered with the Warm Springs TERO, as there will be a need for more employees, Mr. Bisland said.

The TERO provides training to tribal member workers, and helps place them at work projects.

## Resolutions of Tribal Council

*The following are resolutions of the Twenty-Eighth Tribal Council of the Confederated Tribes.*

### For elders

**Whereas** the Tribal Council is the elected governing body of the Confederated Tribes of Warm Springs Reservation of Oregon; and

**Whereas** the tribes desire to petition, by grant application Title VI, Part A and C of the Older American Act fiscal funds to operate program services eligible Indian Elders on the Warm Springs Reservation; and

**Whereas** the tribes agree to abide by all provisions identified in section 614(a) of the Older Americans Act and Title 45 of the Code of Federal Regulations 1326.19(d); and

**Whereas** Indian Elders over the age of 60, and who reside on the reservation will benefit from nutrition and supportive services provided by the Senior Wellness Center during the grant period, which ends on March 31, 2022; now therefore

**Be it resolved** by the Twenty-Eighth Tribal Council of the Confederated Tribes of Warm Springs, pursuant to Article V, Section 1(a), (d) and (s) of the Tribal Constitution and By-Laws, that the Secretary-Treasurer/CEO of the

Tribal Council, or her authorized designee, is hereby authorized to make application for Title VI of the Older Americans Act grant funds, negotiate and execute an agreement, including any amendments thereto, on behalf of the Confederated Tribes of Warm Springs Reservation of Oregon whose authorization shall remain in full force and effect until otherwise canceled or revoked.

*Resolution no. 12,600.*

### Wildfire suit

**Whereas** on August 8, 2017 a wildfire ignited on a private ranch located just north of the Warm Springs Reservation in Wasco County, which became known as the Nena Springs fire, and then spread south and entered the reservation; and

**Whereas** based on the investigation to date, the Confederated Tribes of the Warm Springs Reservation understands that the origin and cause of the Nena Springs fire resulted from human activity in connection with the operation of farm equipment; and

**Whereas** the tribes committed tribal resources to combatting and containing the Nena Springs fire; and

**Whereas** the Nena Springs fire caused damage to forest land and rangeland

of the northeastern part of the reservation; and

**Whereas** pursuant to Warm Springs Tribal Code Section 200.025, the Warm Springs Tribal Court has jurisdiction over the tribes' claims against any persons responsible for causing the Nena Springs fire; and

**Whereas** Oregon's state courts and/or the United States District Court, Dis-

trict of Oregon may also have jurisdiction over the tribes' claims against any persons responsible for causing the Nena Springs fire; now therefore

**Be it resolved** by the Twenty-Eighth Tribal Council of the Confederated Tribes of Warm Springs, pursuant to Article V, Section (b), (f), (l) and (u) of the Tribal Constitution and By-Laws, that

the Tribal Council hereby:

Authorizes the Tribal Council Chairman, vice Chairman, and Secretary-Treasurer/CEO, in consultation with the tribal attorneys, to take appropriate action, including the commencement of legal action, that seeks to recover damages from the party or parties responsible for the damages resulting from the Nena Springs fire,

and that otherwise seeks to protect the tribes' resources and interests; and

Permits the authorized representatives, in consultation with the tribal attorneys, to engage outside legal counsel to represent the tribes in any action that may be commenced in Warm Springs Tribal Court.

# Among the ‘100 Who Made a Difference’

This summer *The Oregon Quarterly*—the magazine of the University of Oregon—is celebrating its One-Hundredth Anniversary. To commemorate its centennial, *The Oregon Quarterly* named 100 Ducks Who Made a Difference.

The magazine chose the 100 by asking readers for nominees. Nominees could include alumni, students, faculty, staff, administrators, and friends of the university from 1919 to the present. The standard for naming the 100 Who Made a Difference: “Those who, through grit, talent, compassion or creativity have made

our world better.”

Among the 100 Who Made a Difference: Class of ’59 graduate Ken Smith of Warm Springs. Mr. Smith earned his Business Administration Degree from the U of O. He was just the second Native American to graduate from the university.

*The Oregon Quarterly* article continues: “Ken went on to serve as President Ronald Reagan’s Assistant Interior Secretary on Indian Affairs, launching programs includes ones to help smaller tribes and Alaska communities.”

For tribes Mr. Smith helped provide seed grants that stimulated new business

and self-sustaining economic development.

Ken, a Wasco tribe member, also served as Chief Executive Officer of the Confederated Tribes of Warm Springs.

Another Native American U of O grad who made the 100 Who Made a Difference

list is Roberta Conner, Class of ’77, a keeper of tribal histories, who also served as board chair for the Smithsonian’s National Museum of the American Indian.

She is now the director of the Tamástslikt Cultural Institute

Prevention camp in Warm Springs

The Confederated Tribes of Warm Springs in August will host the Nine Tribes of Oregon and Native American Rehabilitation-NW Prevention Camp.

The camp, August 12–16, will be at the Warm Springs Community Wellness Center.

We are expecting 120 Native youth and adult chaperones from the nine Oregon tribes and NARA-NW.

Youth ages 13-19 will take part in this year’s camp, providing youth education and skills to cope with depression.

The camp will also provide opportunities for youth, to feel comfortable, in a safe learning and sharing environment. Sessions will encourage youth to open up and talk about their struggles, while also having fun.

Campers will be exposed to two days of intensive learning, cultural, recreational, spiritual and artistic opportunities. Campers will work in teams, break out in groups, mingle and share openly with other peers, as well as present in small or large groups.

A full day will be devoted to recreational activities available around the Warm Springs community, like rafting, fishing, jamboree day, arts and crafts, with powwow and dance at the end of the day.

Remembering Academy dedication

Five years ago this August the Confederated Tribes and partners celebrated the ribbon cutting and dedication of the Warm Springs Academy. The project had been a dream of many in Warm Springs for decades.

Then after months of negotiations, tribes and school district each held votes in 2013—and both elections were successful.

The negotiation and community approval referendum were projects of the Twenty-Third Tribal Council of the Confederated Tribes.

At the time, Urbana ‘Toto’ Ross was the Chief Operations Officer. The late Ms. Ross led the campaign that brought about approval of the Academy referendum.

This allowed the tribes to secure funding, and the tribes and school district oversaw the construction of the Academy.

The new school, with capacity for more than 600 students, opened just before the 2014-15 school year. The dedication was one of the bigger events the tribes have seen in recent years.

## Resolution of Tribal Council

### Lamprey

**Whereas** the Treaty with the Tribes and Bands of Middle Oregon on June 25, 1855 secured to the Confederated Tribes of the Warm Springs Reservation of Oregon the right to take fish at all usual and accustomed stations in common with citizens of the United States, and Willamette Falls of the Willamette River at Oregon City is one such treaty-reserved ‘usual and accustomed’ fishing stations; and

**Whereas** for not less than time immemorial Warm Springs tribal members have harvested eels, also known as lamprey, at Willamette Falls, Bull Run, Sandy River,

Clackamas River, North Santiam River, Deshutes River, 15-Mile Creek, and at other ‘usual and accustomed’ fishing stations to use for ceremonial, subsistence and other purposes; and

**Whereas** it is important as an exercise of sovereignty and to meet the conservation needs for the resource that the tribe actively manage the eel fishery at Willamette Falls; and

**Whereas** Section II J. of the 2018-2027 United States v. Oregon Management Agreement, executed on November 21, 2017 by the Warm Springs Tribal Council Chairman, and on October 31, 2017 by the Director of the Oregon Department of Fish and Wildlife,

which is an order of the Federal District Court of Oregon in case Civil no. 68-513-KI requires a process that includes discussions between the State of Oregon and Warm Springs and other party tribes each year to establish lamprey take (harvest) levels at Willamette Falls each year; and

**Whereas** those take or harvest levels of lamprey at Willamette Falls are man-

aged by and through Warm Springs tribal regulations establishing the time, place and manner of lamprey harvest; and

**Whereas** the State of Oregon did not enter into the process as required by the United States v. Oregon Management Agreement to work with Warm Springs and other party tribes to set the annual take regulations, and unilaterally declared what the 2014 Willamette Falls take regulations would be in a letter dated May 6, 2019, and moreover said letter is represented as a ‘permit’ issued by Oregon for lamprey harvest at Willamette Falls; and

**Whereas** the tribes’ lamprey harvest at Willamette Falls is pursuant to its June 25, 1855 Treaty with the United States, and no license, permit or authorization of any type by the State of Oregon is necessary for the tribe’s harvest of lamprey at Willamette Falls, and therefore the tribe does not acknowledge or accept the purported permit offered by the State of Oregon; and

**Whereas** notwithstanding the State of Oregon’s failure to adhere to the terms of the United States v. Oregon Management Agreement, and while rejecting the May 6, 2019 letter as a ‘permit’ or any emblem of state regulation, the tribe has treated the state’s time, place and manner provisions as its recommendations and advice to the tribe, and those have been considered by the tribe in establishing the Warm Springs tribes’ time, place and manner conditions of the 2019 lamprey harvest; and

## YouthBuild recruiting youth

Heart of Oregon YouthBuild is recruiting youth ages 16-24 years for our Fall 2019 cohort starting in mid October 14.

Through AmeriCorps service at YouthBuild youth can earn the AmeriCorps Segal Education Award worth \$1,566 towards post-secondary goals.

YouthBuild requires a 12-month commitment, along with one year of follow-up services.

archival information, are essential and vital to the sovereignty and history of the tribes, that the Education branch and the Culture and Heritage department will continue its efforts through grants, partnerships, development of materials, and strategic plans that respect the strict control of ownership of the language, culture, and traditions of the Warm Springs, Wasco, and Northern Paiute people, and approving the letter to be signed by Chairman Tsumpti to the Oregon Department of Education Director, Colt Gill. Second by Glendon. Question: 5/0/0, Chairman not voting; Motion carried.

## Resolution: Water safety

**Whereas** the Confederated Tribes of Warm Springs Reservation of Oregon is a federally-recognized tribe who operates the Warm Springs Public Water System, located on the reservation, providing water for human consumption; and

**Whereas** the system serves approximately 3,800 persons including residential, commercial, day care, school, senior center and medical center users; and

**Whereas** the system is supplied by surface water from the Deschutes River, which is treated with conventional filtration at its Dry Creek Treatment Plant; and

**Whereas** the United States Environmental Protection Agency is vested with the authority to enforce the requirements of the Safe Drinking Water Act; and

**Whereas** the Safe Drinking Water Act requires a sanitary survey of the system every three years, and a sanitary survey was conducted on July 18, 2018; and

**Whereas** on November 27, 2018 the EPA provided the tribe with written notice of significant deficiencies in its system and a copy of the July 18, 2018 sanitary survey report, and the tribe did not timely correct the significant deficiencies or provide a corrective action plan that in EPA’s determination could be approved; and

**Whereas** the EPA has issued an Administrative Order on Consent for the system

(attached to the resolution), asserting Safe Drinking Water Act regulatory jurisdiction over the tribe with respect to the significant deficiencies identified for the system; and

**Whereas** the tribe desires to cause the system to remedy the significant deficiencies and comply with related requirements as provided by the consent order; and

**Whereas** by voluntarily entering into the consent order to tribe waives administrative or judicial review regarding the matters addressed in the consent order, but does not otherwise waive any argument about the regulatory jurisdiction of the Safe Drinking Water Act over the sovereign tribe; and

**Whereas** to effectuate the consent order the tribe desires to exercise its sovereign immunity by granting a limited waiver of sovereign immunity; now therefore

**Be it resolved** by the Twenty-Eighth Tribal Council of the Confederated Tribes of Warm Springs, pursuant to Article V, Section (1)(a) and (l) of the tribal Constitution and By-Laws, that the Tribal Council approves the attached exhibit and authorizes the Tribal Council Chair, Vice Chair or Secretary-Treasurer/CEO to execute a finalized version of the attached exhibit; and

**Be it further resolved** by the Tribal Council that the Tribal Council agrees to waive the tribe’s sovereign immunity for the limited purposes of this agreement under the terms contained in the consent order as authorized by Warm Springs Tribal Council Chapter 30.

## Western Cicada Killer spotted in W.S. area

The Western Cicada Killer insect has been spotted in the Warm Springs area, among other Central Oregon locations.

The Western Cicada Killer can be big—up to 2 inches in length.

The numerous recent sitings have prompted multiple inquiries at the OSU Extension Center.

The Western Cicada Killer is often mistakenly identified as a hornet. Its robust body and large size can alarm anyone recognizing it as a wasp, but its focus is not on humans: The Western Cicada Killer focuses on the mid-air insects that will feed its young.

The wasp is native to the western U.S. states and Mexico. The Western Cicada Killer is one of four kinds of Cicada Killers.

People are seeing them in unusually high numbers because there is an outbreak of cicada in central Oregon.

The important thing to remember with these wasps is that while they can sting, they are not aggressive and are not a threat to humans.

As long as we do not step on them, swat or harass them, they are likely to just go about their business of hunting cicadas and drinking nectar from flowers or honeydew from aphid infested

shrubs and trees.

These large wasps are efficient hunters of the loud, plentiful, and nutritious cicadas that buzz through summertime. They attack flying cicadas, a noisy battle that can sometimes be heard by the humans below. The adult females will kill cicadas to feed their offspring and the male and female adults drink nectar from flowers.

Cicada Killers appear as adults often in July, and are mostly seen visiting flowers or digging burrows in sandy or light soil.

The species nests in the ground and stocks its nest with cicadas.

As in many insect species, the males appear as adults first, and mating takes place when adult females emerge from the soil.

After mating, females select a site and being digging a burrow. Favorite sites are embankments, under sidewalks and roadsides.

Females burrow into the soil for approximately ten

inches, with a channel of about half an inch.

Oval chambers are excavated at the end of the burrow, large enough to accommodate a few individual cicadas.

The female then seeks a cicada, apparently by vision rather than sound, suggested because the majority of her prey are female cicadas, which make no sound.

Cicadas are usually captured in flight. Cicadas are paralyzed by the venom of the wasp’s sting, and will remain alive during the feeding of the wasp larvae.

After stinging the cicada, the female wasp carries it back to her burrow, sometimes a hundred yards away. Without the presence of trees or shrubs, she will walk on the ground.

The female Cicada Killer lays one egg in a cell with one, two or three cicadas, then seals the chamber. Cicada Killers adhere to the normal pattern of solitary wasps by mass provisioning their brood cell.

The cells are prepared and completed one by one.

Enough food is provided in the cell for the larva to survive until pupation.

Rarely solitary wasps engage in progressive provisioning, which involves caring for several cells at one time and adding food daily to each cell during the growth of the larvae. The eggs of the Cicada Killer hatch in two or three days, producing larvae that feed for about two weeks, which then spin a cocoon of silk mixed with sand or soil.

The pupal case is held in the center of the cell by silk strands, and the cocoons remain in the chamber through the winter, with emergence as adults in the following summer.

The OSU Extension office located at 850 NW Dogwood Lane in Madras, just north of the Airport off Hwy 26, accepts insect and plant samples for submission to the Master Gardener program for identification and disease diagnosis. For more information visit:

Mobile check deposit has fast become one the most convenient ways to deposit a check: Simply snap a photo of the front and back of the check and deliver the image through the mobile check app.

The check is deposited without having to visit a branch or ATM.

But we also want you to be well informed about the potential for fraud with mobile check deposit.

Fraudsters are devising new check scams while posing as prospective employers or lenders.

**How the scam works**

Fraudsters contact their victims through email or so-

cial media, posing as a potential employer or lender.

This contact may also be done through posting a job advertisement through an online site such as Craigslist.

The fraudster will oftentimes provide the victim with an opportunity to earn quick money by depositing a check to your account, or by asking for help in moving money from overseas.

The fraudster will further request your bank account information, and may even ask for your online or mobile banking login and password.

The fraudster uses the information to deposit a fake check.

Once the deposit has been made, the scammer will request funds to be immediately transferred back to them via money order, person to person transfer, wire

transfer, reloadable cards or even gift cards.

After funds have been sent to the scammer, the check or checks that were deposited will be returned and the funds will be removed from the victim’s account, causing a loss to the victim.

**Protect yourself**

Avoid falling prey to these scams by following these few simple steps:

· Never give out personal information to strangers. This includes your debit card number, PIN, bank account number, and any online or mobile banking login information.

· If you are offered money in exchange for your personal information, it’s likely a scam. Don’t proceed. Scammers could leave you owing thousands.

· Check your online

bank statements regularly. If you see something unfamiliar, call your bank or credit union immediately.

· If you apply for a work-from-home job by email or online and the first thing they do is send you a check to cash then request you to return some or all of the money to them, it’s most likely a scam.

**If You Suspect Fraud**

If you suspect a check is fraudulent, don’t deposit it. Remember, if the offer seems too good to be true, it probably is.

If you believe you have been the victim of a fraudster, contact your local police department immediately and notify your financial institution as soon as possible. They can place additional safeguards on your account.

# CRITFC swears in new officers

Umatilla tribal leader Jeremy Red Star Wolf is the new chairman of the Columbia River Inter-Tribal Fish Commission.

Mr. Wolf was sworn last week as the 2019-2020 chairman, taking the position from Ryan Smith of Warm Springs, who is now the CRITFC treasurer.

The vice chair is Leland Bill, Yakama; and Ferris Paisana, Nez Perce, secretary.

This is the second time Mr. Wolf has served as the CRITFC chair, previously occupying this position in 2016.

Jeremy is the current vice-chairman of the Board of Trustees for the Confederated Tribes of the Umatilla Indian Reservation.

His Indian name, Xitsiv Ilp Ilp, means ‘Red Star.’ He grew up on the Umatilla River in Cayuse. His intertribal relations include the Palouse (Chief Wolf), Nez Perce (Ollicut), Warm Springs (atway Great Aunt Gina Wolf married atway Jazzy Wewa, a Warm Springs member), and Yakama (atway grandmother Theresa Johnson of the Yakama Charlie family).

In 1996 Jeremy graduated from Weston McEwen

High School in Athena, Oregon. After serving a year with Salmon Corps, Jeremy went on to graduate from Blue Mountain Community College, and is an alumnus of Oregon State University’s School of Forestry with a degree in Natural Resources.

Much of Jeremy’s life has revolved around incorporating the unwritten law into the demands of present-day life:

Staying culturally active, earning an education, building a skillset, and staying active in tribal government.

Starting as a summer hire in high school conducting

habitat and monitoring and evaluation surveys for salmon, steelhead, fresh water mussels, and lamprey throughout the Confederated Umatilla Tribes’ aboriginal title lands.

He worked his way up the ranks at the Umatilla tribe Department of Natural Resources Fisheries Program from a Fisheries Technician to a Biologist.

“The four primary goals of CRITFC are: Put fish back in the rivers and protect watersheds where fish live, protect tribal treaty fishing rights, share salmon culture, and provide fisher services,” said Chairman

Wolf.

“Our intertribal efforts to accomplish these goals help ensure that we not only retain and enhance what we have, but also provide resiliency in all our tribal foods and cultural needs into the future.

“Intertribal cooperation can have challenges, but when we work together as sovereigns, we provide leadership in regional federal and state coordination. In working to provide for our people and our futures, I believe we honor the sacrifices and dedication of our elders and ancestors.”

## Resolution: Wildfire suit

**Whereas** on August 8, 2017 a wildfire ignited on a private ranch located just north of the Warm Springs Reservation in Wasco County, which became known as the Nena Springs fire, and then spread south and entered the reservation; and

**Whereas** based on the investigation to date, the Confederated Tribes of the Warm Springs Reservation understands that the origin and cause of the Nena Springs fire resulted from human activity in connection with the operation of farm equipment; and

**Whereas** the tribes committed tribal resources to combatting and containing the Nena Springs fire; and

**Whereas** the Nena Springs fire caused damage to forest land and rangeland of the northeastern part of the reservation; and

**Whereas** pursuant to Warm Springs Tribal Code Section 200.025, the Warm Springs Tribal Court has jurisdiction over the tribes’ claims against any persons responsible for causing the Nena Springs fire; and

**Whereas** Oregon’s

state courts and/or the United States District Court, District of Oregon may also have jurisdiction over the tribes’ claims against any persons responsible for causing the Nena Springs fire; now therefore

**Be it resolved** by the Twenty-Eighth Tribal Council of the Confederated Tribes of Warm Springs, pursuant to Article V, Section (b), (f), (l) and (u) of the Tribal Constitution and By-Laws, that the Tribal Council hereby:

Authorizes the Tribal Council Chairman, vice Chairman, and Secretary-Treasurer/CEO, in consultation with the tribal attorneys, to take appropriate action, including the commencement of legal action, that seeks to recover damages from the party or parties responsible for the damages resulting from the Nena Springs fire, and that otherwise seeks to protect the tribes’ resources and interests; and

Permits the authorized representatives, in consultation with the tribal attorneys, to engage outside legal counsel to represent the tribes in any action that may be commenced in Warm Springs Tribal Court.

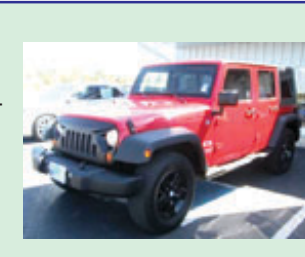
