# Community update

The Indian Health Service for the Warm Springs tribes updated the Covid-19 data for Tuesday of this week, September 7:

On that date there were 11 active covid cases on the reservation, receiving daily monitoring. There were three community members hospitalized with the disease, no one on a ventilator.

Total number of primary vaccinations in the community was at 2,911. Total number of second shots was at 2,435; and 30 individuals had received the third, or booster shot. The booster at this time is available to vulnerable members of the community, such as those at senior assisted living. You can call to schedule a vaccination anytime at the Health and Wellness Center, 541-553-2131.

# Hopeful start to 2021-22 school year

C lasses started this week for students of the 509-J school district. At the Warm Springs Academy the firstthrough eighth-graders started on Tuesday. Half of the kindergarteners started this Wednesday, and the rest return this Thursday.

At the high school, the freshman returned on Tuesday, and the tenth- through twelfth graders returned this Wednesday.

Masks are required to start the school year in the effort to prevent the spread of Covid-19 and to keep everyone safe. No one is allowed in a school district building



without wearing a mask.

School hours at the Warm Springs Academy are 8:45 a.m. to 3:55 p.m., except for the Late Start Mondays, when school begins at 10:15 a.m. with doors opening at 9:55.

At Madras High School and Bridges High School, the school day is from 8 a.m. to 3:05 p.m., except for late start Mondays when school starts at 9:30. For the bus routes, see the district website at jcsd.k12.or.us/

The first day of in-person classes begins at the Warm Springs Academy, as the buses arrive Tuesday morning. For details on the covid safety protocol of all 509-J schools, see page 5 of this publication.

# Roadway progress

The construction company working on the Highway 26 safety corridor project this

week is beginning more paving. This work will be between mileposts 103 and 111.

The work will be at night, from the hours of 7 p.m. to 7 a.m.: Drivers should anticipate up to 20minute delays, as one lane of the highway will be closed, controlled by flaggers and pilot cars.

During the daytime, the contractor will perform excavation and earthwork activities. New curb and drainage pipes will also be installed along the shoulder of the highway.

Warm Springs Construction also continues their safety project along Highway 3. Features here include the pedestrian path along the highway, and rock-fall work.



# Community covid demographics update



The Confederated Tribes Covid-19 Response Team updated the reservation community Covid-19 data, as of September 1, 2021. On that date there were 16 active cases in the community, bringing the overall total since the pandemic began last year to 936.

There were two community members hospitalized with covid on September 1, according to the update. One person had died. Fourteen of the cases were among people with an underlying condition. Total breakthrough cases was 29. (**Note:** The incidence of breakthrough cases demonstrates the vaccine is working, in that vaccinated breakthrough cases are much less likely to result in serious illness, hospitalization, and death.) One case of the delta variant was reported in the September 1 data (*more demographics on page 5*).

# IHS Indian Country covid data

The Indian Health Service updated its coronavirus data, showing results through late last week.

As of that date across Indian Country, IHS testing had returned a total of 232,855 positive tests for covid, since the pandemic and testing began.

Since testing began last

year, IHS had conducted a total of 2,856,618 coronavirus tests.

Based on the cumulative percent positive, the highest rates have been the IHS Navajo Area, the Phoenix Area, the Oklahoma City Area, the California Area, and the Albuqueque Area.

## Vaccines during pregnancy

"We pay—Kids play!"

If you're pregnant, you may be wondering about the vaccinations. Getting vaccinated during pregnancy doesn't just protect yourself, but it can protect your baby

Getting influenza, tetanus, reduced diphtheria toxoid and acellular pertussis (Tdap) vaccines while you're pregnant causes your body to create protective antibodies proteins produced by the body to fight off diseases.

If you get these vaccines while you're pregnant, you pass on some of those antibodies to your baby. Newborns are not yet able to get these vaccines, so this immunity can act to protect your child during those first few months of life.

What about the Covid-19 vaccines? The Centers for Disease Control recommends covid vaccination during pregnancy as well.

The Covid-19 vaccination is recommended for all people ages 12 and older, including people who are pregnant, breastfeeding, trying to get pregnant now or might become pregnant in the future.

Pregnant and recently pregnant people are more likely to get severely ill with covid compared with nonpregnant people. Severe illness from covid during pregnancy can be avoided by getting fully vaccinated.

Talk with your doctor about maternal vaccination.

# Opioid overdose Prevention

The Warm Springs Prevention Team is sharing a training video for the emergency use of the Narcan (Nalaxone) Nasal Spray. The spray is used to treat an opioid overdose. It is the only FDA approved treatment of known or suspected opioid overdose.

Narcan Nasal Spray may counteract the lifethreatening effects of an opioid overdose. Since most accidental overdoses occur in a home setting, it was developed for first responders, as well as famfriends, caregivers—with no medical training required. # Many Vets due for record raise next year

Military retirees and disabled veterans could see their monthly checks jump by hundreds of dollars each month in 2022, the largest increase since 1983.

The annual inflationbased Cost of Living Adjustment, or COLA, soon will be determined by the government, and all the figures point to an increase of at least 6 percent, and maybe more, beginning in 2022.

That means that next year, military retirees will see their monthly retirement check increase, with the average monthly check going up by around \$160.

Veterans receiving disability compensation from the Department of Veterans Affairs also will see their monthly disability

payments increase, with the average monthly amount increasing by nearly \$100.

According to the Department of Defense, there are around 1.87 million military retirees, with an annual average retirement payment of \$30,265.

The VA says nearly 5.1 million veterans receive disability compensation, with an annual benefit of \$18,549.

The annual COLA increase is based on the Consumer Price Index (CPI), which is measured by the Department of Labor. That agency measures the costs of a select group of goods and services and compares those costs to the previous

If there is an increase, retirees and many others receiving government benefits see an increase in their monthly payments for the upcoming year. If those costs go down, the government payments will remain the same in the upcoming year.


In 2021, costs for most goods and services have gone up much faster than they have in the past. The most recent data from the Department of Labor is showing a 5.4 percent increase from last year, and there are two more months left in the current fiscal year, which ends on Sept. 30.

So, unless there is a major turnaround of the economy, with prices dropping dramatically in the next month or so, next year's government payments should see a hefty increase.

The CPI also is used to determine federal employee retirement and social security COLA adjustments as well as other federal benefit programs, so the CPI increase will affect over 50 million Americans.

Next year's COLA is scheduled to be announced in early October. When it is, military.com will have the latest information, including disability pay rates available

# Covid safety mesaures at 509-J

Like students of the other districts of the state, students of the Jefferson County 509-J district return to school with mask requirements. The same applies to teachers and staff inside any school buildings.

The district here clarifies the rules that apply, as this week the 2021-22 school begins. Masks are required at all times during regular school hours and on school buses, except for the following:

Eating or drinking. When an individual is alone in a private room or workspace. When practicing or playing sports.

Performing while playing music, or when delivering a speech or engaged in theater.

Mask exceptions: Accommodations, such as a face shield are available, but limited to legitimate medical reasons or because of a known and documented disability.

Important note: 504 or Individual Education plans are meant for students with documented disabilities. They may not be used by parents to avoid the mask mandate.

**Enforcement:** If a student does not consistently and correctly wear a face covering, school staff will reteach the expectation with grace and patience.

"We will continually provide instruction and positive reinforcement to help all students adapt to this change in our school facilities," the district safety plans states.

"The district will not be punitive; however, if a student continuously refuses to wear a face covering in school, they will be provided with the district online learning option."

Vaccine mandate for k-12 staff: In August, Gov. Brown announced that all teachers, educators, support staff, and volunteers in k-12 schools will be required to be fully vaccinated by October 18.

It is the understanding of 509-J district officials that there will be no option for weekly covid testing in lieu of vaccination. As with other state employees and healthcare workers, religious and medical- and disability-related exceptions will apply.

The district anticipates further details and rules from the Oregon Health Authority.

# Vaccine mandate at Umatilla Tribes

Tribal employees of four Umatilla tribal entities have until September 30 to get fully vacci-

This is an approach that is becoming increasingly common, as the Food and Drug Administration recently gave full approval of the Pfizer vaccination. Previously the vaccine was approved conditionally, as an emergency measure.

The Confederated Tribes of Warm Springs Tribal Council for now has not chosen to mandate vaccination for tribal employees, leaving the decisions to the employees themselves, with encouragement from Council and IHS, the branch supervisors, department heads and enterprises managers.

At Umatilla the approach is different. Though that tribe has held mass vaccination clinics and given a \$50,000 grand prize for a fully vaccinated employee, an estimated 35 employees working at those entities are not vaccinated.

The recent Umatilla directive came from their interim executive director, Teara Farrow Ferman.


The mandate applies to four tribal entities: the Yellowhawk Tribal Health Center, the Umatilla Education Department, the Umatilla Tribal Fire Department, and the Umatilla's Covid-19 screeners.


The Board of Trustees sent out a public statement early this month regarding the matter:


"To lead by example, all Confederated Tribes of Umatilla Indian Reservation Board of Trustee members and officers are fully vaccinated against Covid-19. This order comes after careful consideration of our ability to carry out tribal government and health care services to the community, and the continued hardship on the CTUIR.


"Currently hospitals in the state of Oregon and the surrounding counties are reaching capacity," the Board of Trustees continued in the These graphs show the Covid-19 case demographics on the reservation as of September 1, as provided by the tribes' Covid Response Team.


On the first of this month there were 16 active cases in the community, with two hospitalizations and one death. Total breakthrough cases were 29: The breakthrough cases demonstrate the vaccination is effective, because these cases are much less likely to result in serious illness, hospitlization and death.

"Newly infected people suffering from symptoms of Covid-19 that require respiratory therapy are being transported to other states for Covid-19 emergency care. We are facing shortages in medical care capacities, equipment and protections."

Yellowhawk is approaching 1,700 vaccinated individuals as the tribe braces for a surge in cases. It "will likely become worse after upcoming large local events," the memo stated, probably alluding to the Pendleton Round-Up this month.

Oregon is one of only five states that offers a veteran home loan program—which is separate and distinct from the federal VA Home Loan Guaranty.

ODVA has lent approximately \$8 billion in low-interest home loans more than 334,000 veterans since 1945.

Currently, ODVA's Home Loan Program offers eligible veterans fixed-rate financing for the purchase of an owner-occupied, single-family residence up to the Fannie Mae limit, which has been set at \$548,250 for 2021. The program does not offer refinancing options. The Oregon Veteran Home Loan Program is a lifetime benefit and may be used up to four times.



The Willamette National Forest and Oregon Department of Forestry were both actively engaged with fire managers.

# Zone 6 September tribal fishery

The Columbia River Inter-Tribal Fish Commission and member tribes have set a September fishery.

The zone 6 fishery is from the present to 6 p.m. on Friday, September 10.

Gear is set and drift gillnets with 8-inch minimum mesh size restriction. Allowable sales:

Salmon (any species), steel-

head, shad, yellow perch, bass, walleye, catfish and carp may be sold or retained for subsistence.

Fish landed during the open period are allowed to be sold after the period con-

Sturgeon may not be sold, but sturgeon from 38 to 54 inches fork length in the Bonneville pool, and sturgeon 43-54 inches fork length in the The Dalles and John Day pools may be kept for subsistence purposes.

Closed areas: Standard sanctuaries applicable to gillnet gear. The standard Spring Creek hatchery sanc-

tuary is in place. The zone 6 platform and hook and line fishery regulations remain unchanged.



# First responders fight vaccine mandate

First responders—including some in Jefferson County—are challenging the state of Oregon's vaccine mandate.

The first responders have taken the matter to court, posting plans to defy the order. They also wrote to Gov. Brown, informing her they won't be enforcing mandates in their jurisdictions.

In Jefferson County, dozens of firefighters, the Fraternal Order of Police and State Troopers filed suit in the county court.

The lawsuit alleges the governor's decision to mandate state employees get the covid vaccine by October 18, or lose their jobs, violates the state and federal constitu-

The suit came two days after a trooper in Bend was placed on leave.

"I'll likely get fired for this," Trooper Zachary Kowing said.

In a social media video, Kowing sits in uniform, in his patrol car and blasts the governor, her mandate and anyone who gets the vaccine 'out of fear.'

By mid-last week Oregon State Police had placed Kowing on paid leave pending an investigation.

Portland attorney Dan Thenell is representing Kowing, as well as the plaintiffs in last week's Jefferson County lawsuit. He said the cases are separate, but the point is clear.

"There are many troopers who are not going to get this vaccine and are prepared to lose their job over this," Thenell said.

He's hoping it won't come to that.

The lawsuit argues the governor's vaccine mandate, among other things, violates rights to free expression, under the Oregon and U.S. constitutions.

Thenell calls governor's executive order "unlawful" and says even amid a global pandemic, labor unions should have been allowed to negotiate.

The governor's executive power, even amid an emergency like a global pandemic, doesn't trump bargaining rights when it comes to conditions of employment, the attorney said.

Pushback against vaccine mandates is also mounting nationwide. In Oregon, nurses in Tualatin have rallied against the requirement. The Portland Police Association has warned that officers, under a mandate by the city, will resign over it. And last month, Columbia County Sheriff Brian Pixley told Gov. Brown he won't enforce vaccine or mask mandates, writing in an open letter, "We have had enough of your overreaching mandates and bullying threats."
