Powwow returns to Simnasho

The Lincoln's Birthday Powwow returns to Simnasho in February. This will be the first Lincoln's Powwow since 2020: The Powwow Committee had to put Lincoln's on hold in 2021 and 2022 while the covid pandemic was the serious health threat.

The most recent Lincoln's Powwow-the Forty-Fourth, held in February 2020-was celebrated just a few weeks before the Tribal Council, like jurisdictions across the U.S. and the world, had to declare a public state of emergency because of the virus. During the organization shut-down, large gatherings like powwows were cancelled. So the upcoming Lincoln's will be the Forty-Fifth Annual, though the powwow actually first started 47 years ago.

The Simnasho community will host the Lincoln's Birthday Powwow Friday through Sunday, February 10-12.

The first Grand Entry will be at 7 p.m. on the opening Friday; at 1 p.m. on Saturday, and 1:30 p.m. on Sunday (there is no evening Grand Entry on Saturday).

Specials will be: The Outgoing Queen Special, and the Hat and Boot Special. Also: The Charlie Tailfeathers Memorial Special; and the Men's Traditional 40 and Up. More specials are:

The Women's Golden Age Special. The Men's Fancy Special. The Mother/Daughter Special. And the Cena Wolfe Memorial Special. Plus:

The Women's All-Around, and the Women's 21 and Up. The Men's Fancy Special will be in Loving Memory of Fred Laddie Ike Jr.

New book tells Native story of the river

Warm Springs tribal elder Linda Meanus has written a new children's book—My Name Is LaMoosh—coming out early this summer.


Ms. Meanus grew up with her grandma Flora Thompson and grandpa Chief Tommy Thompson near Celilo Falls. The once mighty Columbia fishery was flooded in 1957 by the construction of The Dalles dam. Linda persevered through this historic trauma and life's challenges to teach young people about the Indigenous ways of the Columbia River.

Intended for young readers to learn more about Native American history through a first-hand account, My Name Is LaMoosh is also a reminder that Indigenous people continue to maintain a cultural connection to the land and river that gave them their identity.

My Name Is LaMoosh includes fact boxes that provide historical, cultural and environmental context for Linda's personal story.

Hundreds of books already exist about Lewis and Clark and their journey of 'discovery.' My Name Is LaMoosh balances our understanding of American history with the long-neglected voices of Indigenous people.

Linda's story is not just about historic trauma but also about resilience, perseverance and

reciprocity. As Linda says:

"It was an honor to do this book. People don't know our history, and I thought it was time to share an original story from the river, from a real historical site."

My Name Is LaMoosh honors the teachings of her grandmother, Flora Thompson, who was a longtime advocate for fishing rights and

Celilo Falls. The book was done in collaboration with Confluence. OSU Press and Dr. Katy Barber. Ms. Meanus and partners wish to thank the Meyer Memorial Trust for providing funding for this project.

Linda is an educator. She shares her knowledge on traditional Indian foods at events across the American West, from elementary schools to the National Indian Child Welfare Association.

My Name Is LaMoosh is her first book.

In getting the book published, she worked with Confluence, a community-supported nonprofit that connects people to the history, living cultures, and ecology of the Columbia River system through Indigenous voices. Learn more at confluenceproject.org

They worked with Oregon State University Press on the project. The OSU Press informs and inspires scholars, students, and curious readers by publishing works of regional importance and lasting cultural value.

"We extend and advance OSU's land-grant mission by cultivating responsible scholarship, promoting creativity, and disseminating ideas and knowledge," the Press recounts.

"In all of our work, we are committed to advancing equitable and inclusive publishing and encouraging diverse voices and viewpoints."

Clearly, My Name Is LaMoosh, will help meet these goals.

\$20.5 million award to CRITFC and tribes

In a first-of-its-kind deployment under Bipartisan Infrastructure Law funds, NOAA this month awarded approximately \$20.5 million for the coordinated management of fisheries, ocean and coastal resources.

The recommended federal funds will significantly enhance existing collaboration among tribal government, states and the federal government, and provide needed capacity to advance their work.

Through this recommended funding, the awards will support projects to advance regional ocean partnerships and data sharing among ocean users, and include the engagement of federally recognized tribes with existing regional ocean partnerships.

Regional ocean partnerships are regional organizations convened by governors to work collaboratively across multiple states, in coordination with federal and tribal governments, on common priorities and challenges.

A total of 13 awards were distributed to tribes and partners:


\$1.1 million will go to four federally recognized tribes or tribal organizations-including Columbia River Inter-Tribal Fish Commission-to support tribal actions related to regional ocean and coastal priorities.

The Mt. Hood area is part of the Ceded Lands of the Confederated Tribes of Warm Springsthe area is part of the 10 million acres of traditional homeland of

the tribes that were subject to the Treaty of 1855.

Under the treaty, the Warm Springs and Wasco tribes relinquished the approximately 10 million acres of land, but reserved the Warm Springs Reservation for use. The tribes also kept their rights to harvest fish, game and other foods off the reservation in their usual and accustomed places.

Recognizing that the Mt. Hood area, including Meadows, is part of the Ceded Lands, Meadows each year hosts events for tribal members. There are berry-picking outings, and coming up in February the Tribal Ski and Snowboard Day.

had to issue a boil water notice for last Thursday, January 19. This was in regard to the Agency water system, and was a precautionary notice while testing of the water was under way.

The Agency water system serves the Campus area and the Heights, West Hills, Tenino Apartments, Elliot Heights, Trailer Courts, Miller Heights, Upper Dry Creek, Sunnyside, Wolfe Point and Kah-Nee-Ta.

When there is a boil water notice, you need to bring tap water to a rolling boil, boil for one minute,

Or use bottled water for drinking, making ice, washing dishes, brushing teeth, and preparing food.

Emergency Management's water distribution hours are 9 a.m. to 4 p.m. week days, and they are open during the noon hour.

California's salmon population plummets amid new threat

They've been pushed to the brink of extinction by dams, drought, extreme heat and even the flare of wildfires, but now California's endangered winter-run Chinook salmon appear to be facing an entirely new threat - their own ravenous hunger for anchovies.

After the worst spawning season ever in 2022, scientists now suspect the species' precipitous decline is being driven by its ocean diet.

Researchers hypothesize that the salmon are feasting too heavily on anchovies, a fish that is now swarming the California coast in record numbers. Unfortunately for the salmon, anchovies carry an enzyme called thiaminase, which breaks down thiamine - a vitamin that is essential to cell function in all living things.

In humans, a critical deficiency of thiamine, or vitamin B1, can lead to heart failure and nerve damage. In female salmon that are returning to rivers and streams to spawn, thiamine deficiency can be passed on to their many hatchlings, which suffer problems swimming and experience high rates of death, researchers say.

Now, with government agencies

and Native American tribes fearing the collapse of the winter-run Chinook, scientists are embarking on a campaign to determine why

the anchovy population has exploded off the California coast, and why winter-run Chinook are seemingly ignoring all other prey.

Remembering Hug-O-Grams

Thirty years ago, Valentine's Day in Warm Springs included the Hug-O-Gram fundraiser. The Hug-O-Gram featured a card created by volunteers that was delivered with a hug.

The card was handmade and featured a Native person with arms out-stretched to give a hug. Lucinda Green recruited volunteers, and Carol Allison helped to create the Hug-O-Gram cards.

The Spilyay Tymoo online archive found several articles about the effort. Some of the items from earlier years:

In 1989 the Wellness Committee helped to coordinate the 'Val-O-Gram' effort to raise funds for the Community Center Reader Board.

The order form described the fundraiser as "promoting healthy communication and giving from the heart through 'Val-O Grams' and 'Hug Certificates' on Valentine's Day."

The cost was 50 cents per Hug-O-Gram.

In 1990, the Valentine's Hug-O-Gram project raised \$238 that was used to buy stuffed animals for the Fire and Safety Teddy Bears for Kids project. 1991's fundraiser donated \$270 to Youth 4-H Clubs in Warm Springs.

Hug-O-Grams in 1992 yielded \$300 that was donated to the 'Lil Miss Warm Springs Pageant to purchase gifts for all the participants.

In 1995, the Recreation Department added balloon and candy heart options to the fundraiser. The cost for a balloon was \$1, if you deliver yourself; and \$2 for Recre-

ation to deliver. The chocolate heart cost

was \$5 to be delivered. They also added a Madras delivery for an additional \$6.

At the present time, while covid is still an issue, it's probably best to not have volunteers hugging people. But KWSO and the Spilyay would like to give a shout out to autwai Lucinda Green for her loving work that benefited community programs and put smiles on folks faces.

This year, the Recreation Department is sponsoring a Valentine's Decorating contest for Warm Springs offices with a theme of *Show the Love NDN Style*.

KWSO is all about trying to win the contest and we are including a tribute to Hug-O-Grams as part of our display. Using a template from the Northwest Regional Lab Indian Reading Series book *Being Indian Is*, we've created a couple graphics that you can use to make your own Hug-O-Gram. The illustrator is Debbie Smith.

You can print our Hug-O-Gram 2023 out and color it—Hug O Gram Girl and Hug O Gram Boy—or use a computer program like Paint to color the digital file of the images.



This is the second article in a four-part series on coping with grief and loss.

You might find that your grief comes to you like waves in the ocean. Initially, like a shipwreck, the emotional waves can seem to be overtaking you and you may feel like you will never come out of it. You can feel as if you are drowning in grief.

There will be moments when things are calm and you can feel almost normal and happy, just for a little while. However, before long, another wave of grief comes, sometimes bigger and more consuming than the one before.

This unpredictable and intense emotional process may make you feel you are losing your mind or going crazy. However, it is a very normal process.



However, for a long time, the waves of grief can be very chaotic, challenging, and consuming. You will be very tired, it may be hard to engage in self-care, and you will feel lost at times.

Gather a strong and dependable support group around you. Make sure your closest people are ones you can be honest, raw, and vulnerable with.

If you are a friend of someone who is grieving, make sure to stay with them for the long haul, for all the waves, not just the initial ones. You are not alone, if you need support, dial 988 for the national crisis hotline.

Little League: Volunteers make the season

There is a great reliance on adult volunteers in order to make the Little League season happen, Mr. Francis said. Each team, for instance, requires three adult volunteers: Two coaches and a manager. For 18 teams, that would be 54 volunteers. More help is still needed before the February 28 deadline, Edmund said.

Without enough volunteer adults, the number of teams would have to be reduced, disappointing for the players.

Anyone interested in helping out, there are various team divisions that would welcome the participation. Divisions are from t-ball for 4 and 5 year olds, up to the Senior divisions, in both baseball and softball

The ongoing tradition

As community elders remember, the tradition of organized Warm Springs youth baseballwith official team line-ups, coaches, score- and win-loss record keeping-goes back decades, at least to the 1950s. And there are some interesting aspects to the early years: The role that the Warm Springs VFW, and BIA Roads played in starting the very first league. And the fact that in 1963 the Warm Springs Minors team-the 11- and

12-year-olds-won the state tournament, held that year in Astoriaeven early on, clearly a tradition to be taken seriously.

As a note: The coaches of the Championship 1963 Warm Springs team were Dick Souers and Ed Spino, both of BIA Roads; plus a young Frank Smith, age 13 at the time, who was also playing that year in the Warm Springs Babe Ruth League.

As Mr. Smith recalls, the first Warm Springs youth baseball leagues were in the 1950s. Members of the Warm Springs Veterans of Foreign Wars organized the program. There were PeeWee teams-the 11- and 12-year-olds-; and four Babe Ruth League teams for older kids. The adult organizers and coaches were veterans who had served during World War II, Mr. Smith recalls.

Some of these gentlemen were Alvin Smith, who after military service became manager of Warm Springs BIA Roads; and Milan Smith Sr., BIA Roads roller operator. And Elmer 'Sheriff' Quinn and Cy Katchia, who both were BIA Roads Surveyors. And Mr. Ed Spino, heavy equipment operator. Also in the early years, Russell Bobb started the youth minors league.

To give an idea of how things

have changed since the early days: The ball fields were located where the Pi-Ume-Sha powwow grounds are now. The current Community Center was not there yet. In its place was the community barn. There was a creek with a wooden bridge in the area of the Tenino-Hollywood Boulevard intersection. The adult baseball field was on the land that is now the clinic.

Frank Smith played from a very young age up to his late teens. He was a pitcher, like his brother Claude Jr.

Frank has passed the baseball tradition on to his son Ty Smith, who lives in Ohio and earned a Coach of the Year award for his work with youth teams in the Columbus area. Ty's son David plays in an adult summer league, and daughter Tashina plays softball at the University of Ohio.

Though many things have changed around the reservation since the early days of youth baseball, some things are the same: The young players are still having fun and learning new skills throughout the season. And another thing: Frank Smith-sixty years after he helped coach that state championship team-is still coaching, assisting this year's teams and players with baseball techniques and knowledge.

Funding for cost-cutting home energy upgrades

More resources are available in 2023 to help people cut their energy use and lower their energy bills. The federal tax credits are for upgrades that make homes more energy efficient and comfortable.

The credits are part of the Inflation Reduction Act, which makes it easier for people to cut their energy use.

The new tax credits, together with cash incentives already offered by Energy Trust of Oregon for both electric and natural gas upgrades, mean utility customers in Oregon can save more on items and equipment that may lead to a significant reduction in energy costs.

In addition to the energy efficiency tax credits, the Inflation Reduction Act also updated and extended tax credits for investments in renewable energy and battery storage systems.

As of January 1, federal tax credits are available for the following upgrades, which can also be combined with incentives from Energy Trust for customers of Portland General Electric, Pacific Power, NW Natural, Cascade Natural Gas and Avista. The credits are as follows:

Home insulation: Up to \$1,200; or up to \$1.50 per square foot. Windows: Up to \$600; or up to \$1.50 per square foot depending on efficiency rating.

Heat pump: Up to \$2,000. Central air conditioning: Up to \$600. Natural gas furnace: Up to \$600. For more information see the website: energytrust.org


