# Getting ready for skatepark opening

Workers are putting the finishing touches on the new Warm Springs Skatepark at Elmer Quinn Park. The concrete structure is impressive with a large skating deck area, quarter and half pipes, mini ramps, vertical ramps, spines and extensions, to use the skatepark terminology.

The project has been a volunteer and non-profit effort, bringing a new activity for the youth of the reservation, said Michael Collins, manager of tribal Managed Care. Mr. Collins has been the local lead person in coordinating the construction, working with Tactics skateboards and The Skatepark Project.

The new park replaces the previous wooden ramps that had been in place for almost 20 years. Some other added new features at the park will lights for nighttime skating, and a frisbee golf course.

The grand opening for the skatepark will be next Wednesday, March 29 at 11 a.m. There will be a blessing ceremony, guest speakers, the ribbon cutting, skateboard demonstrations, a DJ, food, giveaways and more.



JoDe Goudy, of Redthought.org and former Yakama Nation Council chairman, will give the morning keynote address on the final day of the conference. Wednesday morning will also feature the silent auction winners, closing ceremony, retirement of the flags and Farewell Dance. # Warm Springs case shows complex legal question in Indian Country

Legal jurisdiction in criminal cases that arise on tribal lands is a confusing subject, at times even for the experts in the field. This is because a number of unique legal factors come into play when a crime happens on tribal land. Some of these factors include whether the defendant is an Indian or non-Indian; whether the crime is major or minor; whether or not there is a victim of the crime, and whether the victim is Indian or non-Indian, for instance. Some of the questions remain in dispute to this day, as shown by a case—still making its way through the court system-that happened in 2016 on the Warm Springs Reservation. Jurisdiction refers to the power of a court over a particular person or matter. Criminal jurisdiction can be tribal, federal or state. Usually, for major crimes in Indian Country the jurisdiction is with the federal government, except in some cases when the suspect is non-Indian and the victim is non-Indian. Then the jurisdiction can be with the state court.

Court, as the case has already been ruled on by U.S. Ninth Circuit Court of Appeals, and then appealed by the defendant to the U.S. Supreme Court. The question involves criminal jurisdiction in Indian Country. What happened was the defendant apparently attempted to elude police while on the reservation. Tribal police arrested the person, who was charged in federal court. He was charged with violating Oregon state laws. The point of contention is summarized as follows: "The defendant filed a motion to dismiss the indictment on the ground that the federal government lacked jurisdiction to charge him in federal court for a state law violation alleged to have been committed by an Indian in Indian country." The case involves legal interpretations of the federal Assimilative Crimes Act; the federal General Crimes Act; and the federal Indian Country Crimes Act; plus the state law regarding fleeing or attempting to elude a police officer. After much litigation so far, the case is on appeale to the U.S. Supreme Court, a clear indication of the complexity of criminal jurisdiction in Indian Country.

# Lingering impact of covid school closures

Many young people in the are behind in school, yet the vast majority of parents think their own child is performing at grade level.

The disconnect is not new, but after the Covid-19 school closures, the stakes for children have in many ways never been greater.

Opportunities to catch up are available in some places, thanks to federal pandemic aid, but will likely dry up in the next few years.

A 2022 Learning Heroes survey of 1,400 public school parents around the country showed 92 percent believed their children were performing at grade level.

But in a federal survey, school officials said half of all U.S. students started this school year behind grade level in at least one subject.

Looking at the most recent overall Report Card for the Warm Springs Academy, for the 2021-2022 school year, English Language Arts, Mathematics and Science test results were all below the state average.

Attendance was also lower than the state average. Tony Cortazar works with

families on attendance issues at the Academy. "Kids are coming in late every day some kids consistently, and some here and then," Mr. Cortazar said.

"I understand weather and transportation issues can be a barrier especially this time of year, but this is a problem especially for some of our younger kids in k- through third grade."

Cortazar adds, "They start off their day with reading. If they get here 10 or 15 minutes late, then they still need another 10 or 15 minutes to eat breakfast. By the time they get into the swing of things, they may have missed the whole lesson, and that puts them behind academically."

Being late and leaving school early does impact learning with kids.

# Non-tribal salmon season closing early

The non-tribal salmon fishing season for most of Oregon and all of California could be closed this year, according to proposals from the Pacific Fisheries Management Council. In California, fall-run Chinook salmon are expected to have severely low numbers in the Klamath and Sacramento rivers, mostly because of drought.

Meanwhile, regarding ocean fisheries, federal regulators overseeing West Coast fisheries have effectively called off California's entire 2023 ocean salmon fishing season, in an effort to protect fish populations that have dwindled during the ongoing drought.



# New WSCAT program focusing on tech, workforce

The Warm Springs Community Action Team has developed a new Technology Workforce program, currently in the process of capacity building. Sara Dowty is the Community Action Team Technology Workforce Analyst.

"The program is currently focused on researching the technology needs, and researching technology training opportunities," Ms. Dowty said. "We're researching local technology companies, and beginning to create the technology workforce program." Sara explains:

The new program will be training local Warm Springs tribal members in the field of technology. The plan is to create skilled tribal members in the field of technology, with a positive impact in Warm Springs.

"The technology workforce program plans to create a long-term positive change for the local community," Sara says.

The program will provide training opportunities to increase technology in IT-information technology-and computer skills. The program will also assist individuals in job placement, and will be a technology resource.

The WSCAT Technology Workforce program is planning to create a solar installation, solar maintenance and solar training program.

This may include collaborating with other businesses in the local area to purchase equipment, provide apprenticeships, internships, or other training opportunities.

"Our project will help bridge the skill gap and create a skilled tribal workforce to ultimately assist in sustaining tribal sovereignty," Sara says.

WSCAT recently applied for a small grant to purchase technology, to be used to create a computer lab area. "We will be purchasing laptops, hot spots, headphones, and other technology equipment that will be needed for a training program," she said.

"The goal is to create a computer lab area where the Technology Workforce participants will come and attend computer classes to learn," Sara said.

WSCAT has identified some of the basic technology and employment needs in Warm Springs and will work with low-income individuals to build the skills needed to be successful.

Importantly for now: WSCAT and the Technology Workforce prorgam are seeking tribal member input.

The survey will be used to help develop the local community-Technology based needs Workforce program: "Tribal member input is vital to creating a program around what the local Warm Springs residents are interested in learning," Dowty said.

Completing the survey and providing valuable input will be vital in the creation of the new program.

WSCAT's goal is to provide tribal members assistance by bridging any gaps or barriers that may hinder training opportunities in the field of technology. The information may be used when applying for future grant opportunities to obtain funding for future technology workforce training opportunities for tribal members.

"Your participation in the survey is greatly appreciated," Ms. Dowty says.

The survey is open for youth working age 14 and over. "It will be particularly interesting to know what technology the youth are interested in as well," she says.

The Technology Workforce program may focus half of its effort on working age youth to develop their computer skills and interests.

There may be winter, spring and summer computer technology and solar camps. and there may be some digital arts classes for youth as well, as an example.



### IHS lifts mask requirement

Warm Springs Indian Health Service has lifted mandatory masking requirements for patients, staff and visitors at the clinic.

Because community transmission and infection rates for covid have remained low, the masking requirement has been dropped.

If transmission rates increase to high levels again, masking may be resumed. Masks will remain available at the clinic.

Please note: For anyone entering the Health and Wellness Center with respiratory symptoms, you are asked to mask, cover rour cough and, clean your hands frequently to help prevent the spread of illness.

### Chieftainship

I am Raymond Tsumpti Jr., son of Wauna Calica (Wasco) and Raymond Tsumpti Sr. (Warm Springs). I've learned that certain members of the Wasco community have stood up to claim that an election should take place for our next Chief of the Wasco people. Unfortunately, the claim has come very late in the process because our late chief had already selected a sub-chief in August 2016 without any objection from the community.

According to the Tribal Constitution, Article four, section eight, the taking of the Oath of Office is subject to all Tribal Council members who are elected into office, and any tribal

executive officers appointed by Tribal Council shall uphold and defend the United State Constitution and the Tribal Constitution and By-Laws. In addition, these Tribal Council members can enforce the due process clause and equal protection clause for all tribal members of the Confederated Tribes of Warm Springs Indian Reservation of Oregon.

Since the late Chief selected a sub-chief by traditional norms and customs of the Wasco Tribe, and with his passing the duly appointed sub-Chief is now our Wasco Chief, and shall be sworn in as soon as possible to protect the U.S. Constitutional rights to equal protection under the laws of the U.S. Constitution, and shall not be denied due process of the law in life, liberty and property. In this case, Wissie Smith was selected by the late Chief in our accepted customs and norms of the Wasco Tribe in 2016 without any objection from anyone.

Now, during 2022 and in 2023, we have a group of tribal members who are forcefully attempting to impose their will on the rest of the Wasco Tribe by circumventing established tribal traditions and norms of the Wasco people to disenfranchise and unconstitutionally unseat the current sub-Chief Wissie Smith. The group or groups of people unlawfully trying to impose an election for our Wasco Chief is not supported by any organic legal document to establish such claims of elections. Our Tribal Constitution does not

specify a procedure to support their claim of an elected Chief of the tribe.

Our Tribal Constitution supports the actions taken by the late Chief to select a successor by allowing the sub-Chief ceremony to take place as recognized by our tribal customs and traditions. Under Constitutional laws, the opposing parties violate the sub-chief's Constitutional protected rights of equal protection. Therefore, they shall not deny him the life of Chief without due process of law.

Since there was a vast amount of time when the sub-chief ceremony took place roughly six to seven years ago, the opposition of the selected sub-chief should have known that a timely objection should have taken place at that time. And the doctrine of Laches prohibits untimely protests in this instance. Therefore, I call upon the representatives of the Wasco people to officially recognize our next Chief Wissie Smith and swear him into office as soon as possible. Respectfully submitted,

# Seeking OHSU On Track! Warm Springs liaison

The Oregon Health Sciences University-OHSUseeks to hire a Warm Springs liaison for the program, OnTrack OHSU!

The position is the OHSU tribal representative, helping recruit young people into the health care field.

This is a full-time job, Monday through Friday; though hours will vary with some nights and weekends required. The salary range is \$25.61 to \$34.63 per hour, depnding on education and experience.

On Track OHSU! is part of OHSU's Office of Science Education Opportunities; and is a health science pathway program working to increase the racial diversity of OHSU's schools and programs, and in Oregon's biomedical workforce. On Track! works with students starting in sixth grade, and stays with those same students through high school and college. On Track! has been working with students since 2013, and is currently partnering with communities in Warm Springs, North Portland, Woodburn, Chiloquin, and Klamath Falls, focusing on tribal, black, and latinx students. As a member of the Office of Science Education Opportunities team, the On Track OHSU! Problem solving skills are important tools for managing stress and reducing the feeling of being overwhelmed.

Having these skills has also been shown to reduce feelings of stress, suicidality and substance abuse, while increasing feelings of competency and fulfillment.

Here are four ways to build your problem solving skills:

· Identify the problem you are facing. Write it down in basic terms.

• Decide that you want to address the problem. Write down why you want to.

· Seek ways to understand the problem more fully. Write down ideas you have that will help you with this.

· Identify solutions that will work.

Now you are ready to take action and resolve the problem. Sometimes having a timeline and support will help.

Just remember, You can do this!

#### Pat Courtney Gold ~ 1939-2023

Pat Courtney Gold, renowned Wasq'u basketmaker, passed away on February 1, 2023. She was 74.

Ms. Courtney Gold was born on January 22, 1939, and grew up on the Warm Springs Reservation. In her youth, she attended a Bureau of Indian Affairs boarding school, went on to earn a BA in Mathematics and Physics from Whitman College, and became a professional mathematician and computer specialist.

Childhood visits with her mother to museums, displaying traditional Wasq'u artwork, inspired Pat to study and help revive the full-turn twining technique, unique to her tribal community.

The result was a resurgence of Wasq'u 'sally bags,' twined root-digging bags with a traditional function for harvesting and storing traditional food.

The baskets were important because they were vital con-

tainers, Pat said: "We would catch the salmon, filet them, dry them and sell them as filets, or we would pound the filets into a powder salmon-like pemmican. That's what we traded. So the baskets were constantly being made, because when we would trade the salmon we would trade a container and all.

"I always thought that was an interesting way to keep the skill of making baskets going.

"It's impossible to overstate the significance of awakening this sleeping tradition, which restores Indigenous wisdom and knowledge, revitalizes cultural form and function, and embodies Indigenous values and pride in ways that have therapeutic impact on intergenerational trauma."

By 1991, Pat was following a new career path dedicated to preserving of her cultural heritage.

She became a participant in Oregon Folklife programming in 1995 during Oregon Historical Society administration by folklorists Carol Spellman and Nancy Nusz. Pat's work was widely recognized for artistic excellence and merit.

She was a 2001 recipient of the Oregon's Governor's Art Award; a 2003 honoree of the First Peoples Fund Community Spirit Award and their 2004 Cultural Capital Fellow; and the National Endowment for the Arts bestowed upon her the highest honor given to traditional artists, the Heritage Fellowship, in 2007.

She accepted numerous speak-

ing and exhibiting opportunities in the Pacific Northwest, nationally including the Smithsonian National Museum of the American Indian—and internationally in countries including China, New Zealand, Canada and England.

Ms. Courtney Gold's art is exhibited at the High Desert Museum, Royal British Columbia Museum, and the Peabody Museum of Archaeology and Ethnology at Harvard University.

Like so many of our nation's finest traditional artists, Pat explored her creative boundaries beyond traditional structures.

During Pat's 2009 Eric and Barbara Dobkin Native Artist Fellowship at the School for Advanced Research, Santa Fe, Pat utilized School of Advanced Research collections to research and gain inspiration for what became her twodimensional wall hangings.

One of these weavings is proudly displayed in the Indian Arts Research Center vaults. A School for Advanced Research documentary video of Pat's time in residency provides a heartwarming glimpse of the thoughtful way she explored her culture, her relationship with the land, and her expressive creativity. Pat was engaging audiences through Oregon Folklife Network programming as recently as 2016, and giving interviews as recently as November 2021.

In her public presentations, Pat married the skills of a trained mathematician and traditional artist, describing baskets as spirals and twining as binary computation.

She captivated Indigenous and non-Native audiences alike, weaving left- and right-brain perspectives like cordage. Many have been blessed by Pat's gifts of time and talents.

We celebrate her life and trust that her invaluable impact on culture will endure.'

# Arrest, hearings in fatal wreck case

A Bend woman was arrested this month on multiple counts of first- and seconddegree manslaughter, and driving under the influence. The defendant in the case remains in custody.

Following a court hearing earlier this week, the judge in the case decided to keep the bail amount at \$1 million. Another pre-trial conference in the case is tentatively scheduled for next week in Jefferson County Circuit Court.

The arrest and charges came after the investigation of a motor vehicle wreck in November that took the lives of three people, including two teenagers, from Warm Springs. Spino-

Saralee

McCormack, 29, and her 13year-old nephew Jesiah Johnson, passed away from injuries at the scene of the wreck, November 16. Jessica Johnson, 15, Ms. Spino-McCormach's niece, died a few days later from injuries.

The wreck happened in the evening during dense fog. Despite the hazardous conditions, Audry Cooper McHugh, 29, of Bend, attempted to pass several vehicles, according to police and Jefferson County District Attorney's office investigation indicates

McHugh's vehicle then collided head-on with the westbound vehicle driven by Ms. Spino-McCormack, killing her nephew Jesiah, and critically injuring her niece, Jessica, who passed away at the hospital a short time later.

Following an extensive and thorough motor vehicle accident reconstruction investigation, McHugh was arrested this month on three counts of first-degree manslaughter, three counts of second-degree manslaughter, and one count of driving under the influence. At the time of the wreck, McHugh was apparently traveling at a speed of 85 miles and hour while under the influence of alcohol and THC, according to the investigation.

A conviction of first-degree manslaughter in Oregon, like aggravated vehicular manslaughter, is a Class A felony, and carries of prison sentence of up to 20 years.





The students will have fun learning the names of items of everyday clothing by playing a memory game.

**OBJECTIVES:** The student will be able to:

- 1. Name five items of everyday clothing, for full control.
- Say "I'm going to \_\_\_\_\_" and "I'm taking a \_\_\_\_\_", for full 2. control.
- 3. Say "I forgot" and "I don't know" for full control.

#### **PROCEDURES:**

#### 1. Introduction:

The teacher will bring a suitcase with her to class. She will open it and show the empty suitcase to the class. She will tell them that we are going to take a trip to Las Vegas in the summer (or Burns in the winter, etc) and that we need to pack clothes. She will ask the students "What will you take with you to Las Vegas?"

Then it will start again. The teacher can keep count and tell the students how many items they remembered each time they play.


